Meeting Minutes for the August 24<sup>th</sup> meeting of the Eagle Ridge Board of Directors

The meeting was held at 865 Soaring Circle, called to order at approximately 7:00p.m. having all Board members present with the exception of Alice. George Todd, Chairperson/Secretary of the ACC Committee, was also present at the meeting.

Discussion regarding the new ACC Committee:

There are two new projects under way:

- Complaint Form on the website as an avenue for homeowners to reach the ACC with their issues.
- Newsletter as a preemptive means to educate homeowners of the covenants and to inform homeowners that the ACC will be taking action to see that they are enforced, allowing time for compliance before any notices are served.
   [The newsletter is subject to approval by the Board before distribution.]
   Following the newsletter, the ACC will conduct a review of the neighborhood, prioritize issues, and begin contact.

[The board approved the process with oversight privileges]

The ACC has set up regions within the subdivision, with approximately 50 homes per region, to better enable tracking and reporting. Contact with homeowners must be consistent, and equitable in relation to the issues at hand.

Two pronged approach for contact with homeowners out of compliance:

- Personal visit to discuss the issue(s)
- Follow-up letter: either thanks for the corrective action, or have not complied with a next step request.

George reported success with this method in reference to a clean up of property on Drive. Requests from the ACC to the Board:

- An increase in dues to cover any legal fees, and to cover an enhancement project to the front entrance \$2.00 increase with the next collection]
- A list of rental properties to clarify which issues the ACC will handle (owners) vs. which will fall to the Board (renters) [*To be delivered by Alice*]
- Business cards for the ACC Committee members [Approved]

The ACC will email the Board with their meeting minutes. Les will be the point person to respond for the Board, after gaining input.

The next ACC Committee meeting will be held September 11, at 864 Soaring Cr. from 6:00-7:00 p.m.
